# 2012 Campus Security Annual Report

Including Crime Statistics for the 2009, 2010 and 2011 Calendar Years

In accordance with the "Jeanne Clery Disclosure of Campus Security and Campus Crime Statistics Act", the following is the annual Klamath Community College "Campus Security Report." The information contained within is provided to inform the faculty, staff and students to assist them in their personal safety.

## **Campus Safety**

It is the highest priority for Campus Safety to continue to keep the Klamath Community College (KCC) campus a safe environment. Our primary responsibility is protecting the safety and physical security of our campus community members. KCC currently employs one full time "Campus Safety Specialist" and "Evening Campus Liaisons". All Safety personnel are certified through the State of Oregon and possess the appropriate" Unarmed Professional" certificates from the Department of Public Safety Standards and Training.

## **How to Report a Crime**

We highly encourage anyone witnessing a crime or suspicious circumstances to report it to Campus Safety immediately. If the crime is **serious** call "911" first, and then contact Campus Safety. Campus Safety will call the Klamath County Sheriff's Office in the event of any emergency. Campus Safety will take an incident report for incidents that occur on campus and will encourage the reporting person to call the Klamath County Sheriff's Office for criminal incidents. The front desk of KCC can also be reached by any campus phone by dialing "0". Evening Campus Liaisons will be available to escort you to your vehicle during the night hours. ## **Emergency Notification**

In the event that a situation arises that constitutes an ongoing or continual threat to our campus attendees, a campus wide "**timely warning**" will be issued.

KCC has several methods of an emergency notification. They are as follows;

- 1) Email notification
- 2) Texting for those who have voluntarily signed up.
- 3) Digital sign notifications, the KCC front entrance sign, and signs in building 4 and building 6.
- 4) Facebook and Twitter
- 5) In the event of a fire, alarms will be activated, please evacuate the buildings and assemble at the evacuation Assembly areas. (Listed on the KCC website under "Campus Safety")
- 6) If safe, we will have KCC staff use bull horns, if necessary.
- 7) In the hallways of each campus building is a map of the fire exit routes and locations of the Assembly areas.

#### **Sex Offenses**

KCC and the Student Government offer educational programs to the student community about sexual assaults and date rape utilizing the local experts. To receive information on the programs or handout information, contact Julie Murray-Jensen at 541-880-2221.

If you are a victim of a sexual assault, your first priority should be to get to a place of safety. Call the Klamath County Sheriff's Office (911) or the Klamath Crisis Center at 541-883-RAPE (7273). KCC strongly encourages victims of sexual assault report the incident in a timely manner. Time is a critical factor for evidence collection and preservation.

KCC personnel will assist the student in notifying the authorities, if the student requests the assistance of the KCC personnel. KCC personnel will refer the student to several local agencies for services of victims of sex offenses and mental health services.

#### **Sexual Offenders**

In accordance to the "Campus Sex Crimes Prevention Act" of 2000, which amends the Jacob Wetterling Crimes Against Children and Sexually Violent Offender Registration Act, the Jeanne Clery Act and the Family Educational Rights and Privacy Act of 1974, KCC refers all inquiries for local sexual offenders to; <a href="http://sexoffenders.oregon.gov/">http://sexoffenders.oregon.gov/</a>. If any sexual offenses occur on campus, please notify Campus Safety at 541-880-2314 or KCC Administration at 541-882-3521 immediately.

#### **Sexual Harassment**

KCC College Board policy 750.0180 is committed to maintaining a learning environment that is free of sexual harassment.

Sexual harassment includes any unwelcome sexual advances, request for sexual favors and other verbal or physical conduct of a sexual nature made by a member of the staff to a student, a student to another student or by a student to a member of the staff.

Any student or employee who is subject to, or knows of, sexual harassment should immediately notify the Executive Director of Human Recourses.

### **Alcohol and Drug Awareness**

KCC maintains a campus free of alcohol and drugs and promotes a healthy and safe environment for its students. The Drug and Alcohol policy and procedures can be reviewed on page 41 of the student handbook.

### **Access to the KCC Campus**

During business hours KCC will remain open until classes have concluded. Building 6 will remain open until 10pm on class days and 8am to 5pm on Saturdays during the quarterly terms for student access.
