- be enrolled in an EAO eligible program at KCC during a current or upcoming term,
- attest to not being eligible for Title IV Federal Financial Aid (FAFSA),
- describe need for funds.
- provide documentation for specific expenses for which funds are sought.

EAO funds support KCC students who are not eligible for traditional Title IV financial aid (FAFSA) in programming such as:

- non-credit workforce skill or pre-apprenticeship training,
- adult education GED/ESL (K-CET),
- registered apprenticeships,
- SBDC and entrepreneurial programming,
- credit based academic programming and not FAFSA eligible.

EAO funds can be used in a variety of ways, including Tuition and Fees, the purchase of technology in support of schoolwork, and tools or equipment needed to successfully complete your studies or training. EAO scholarships are capped at \$500 per educational year – Summer Term through Spring Term
