## International Student 2025-2026 Financial Guarantee

United States Citizenship and Immigration Service (USCIS) regulations require documentation that sufficient financial resources are available to meet a student's prospective educational and living experiences wile in the U.S. Therefore, Klamath Community College requires a guarantee of financial resources from each applicant who expects to obtain or maintain Student (F1 or M1) Status. Applicants are required to submit financial documentation that equals or exceeds one full year of educational and living expenses. A Certificate of Edibility (I-20) will not be issued until this information is provided. An original bank statement dated within the last six months showing the total estimated funds is required in addition to this form.

## **ESTIMATED EXPENSES**

The amounts listed below are estimates and are subject to change without notice. Historically, total costs have increased on an average of 5–10% each year. Students can expect adjustments in the amounts listed on the Certificate of Eligibility (I-20), which will reflect estimates for the upcoming year. This estimate is based upon 12 lecture course hours each quarter for nine months and a homestay/room rental.
