## IP Student Scholarship Financial Guarantee

United States Citizenship and Immigration Service (USCIS) regulations require documentation that sufficient financial resources are available to meet a student's prospective educational and living experiences wile in the U.S. Therefore, Klamath Community College requires a guarantee of financial resources from each applicant who expects to obtain or maintain Student (F1 or M1) Status. Applicants are required to submit financial documentation that equals or exceeds one full year of educational and living expenses. A Certificate of Edibility (I-20) will not be issued until this information is provided. An original bank statement dated within the last six moths showing the total estimated funds is required in addition to this form.
